### **GOAL AND OBJECTIVES:**

The overall goal for this course is to enable Master level students to make use of the tools of critical reflection to examine their personal identity and theological understandings through the creation and implementation of a learning covenant.

The specific goals and competencies are:

1. To formulate a personal learning covenant (goal) after reflection and feedback from others.
2. To establish personal goal(s) for ministerial competence and develop a practical and achievable learning covenant. To locate a mentor and or support group to work with you in the process.
3. To gain measurable appreciation for one's own gifts (abilities) and limitations or hindrances to further discover the personal identity boundaries of ministry.
4. To work within a structured group environment using the resources, insights and feedback of the group and the faculty for understanding personal identity issues and sharpening ministerial effectiveness.
5. To work holistically, synthesizing theological knowledge, ministerial experience and personal identity.
6. To name and state clearly the learnings derived from the process and the covenant.
7. To examine the "Call" to pastoral ministry.

## **REQUIREMENTS:**

1. The Personal Identity and Pastoral Call – Practicum I, Student Manual is the basic guidance for the student.
2. The nature of the class is such that students need to pay particular attention to the process and pedagogical approach to learning. Each student is required to develop a learning covenant or contract which will guide them thorough the course. Ingredients to the process are: setting of goals, meeting deadlines, producing updates, final report, presentation and working with a local mentor.
3. Participation in class which includes peer evaluations, attentiveness to the needs of ourselves and others, identification of your own learnings, prayer, faith sharing and written and oral presentations
4. Student is responsible for each element or phase of the course and corresponding deadlines.
5. Preparation for the first class session. The Practicum I Student Manual outlines the assignment which is to be completed prior to the first class session. See student manual Part IV – Check Lists and Assignments.
6. Faithful active class attendance.
7. The student is also responsible for meeting with the mentor monthly and securing his or her final letter as described in the manual.
8. All written work submitted, as described in the student manual, is expected to meet the STM writing guidelines. Work should be typed and double spaced.
