- II. Provost Fellows & Reignite the Curriculum Update John Fleming and Charles Tung

The Academic Affairs Program Manager, John Fleming, and Special Assistant to the Provost for Curriculum, Charles Tung, updated Academic Assembly on the new Provost Fellows for *Reigniting Our Strategic Directions* program. The Provost Fellows will represent and embed faculty leadership and scholarly expertise through the planning and implementation of *Reigniting Our Strategic Directions*. Tung reported that nearly 60 applications were received for the fellowships. He also mentioned much of the work will be done at the program and department level, and there will be more opportunities for faculty to get involved in the implementation of the goals set forth in the strategic directions. Additionally, fellows will be recognized at the Faculty Convocation in May.

## III. Faculty Handbook Revision Committee Memo Approval Jodi O'Brien and Kirsten Thompson

The Chair of the Faculty Handbook Revision Committee (FHRC), Kirsten Thompson, and Special Assistant to the Provost for Faculty Development, Jodi O'Brien, introduced a series of proposed amendments to the Faculty Handbook to enhance the status of term faculty. The proposed amendments include making term faculty eligible to receive emeritus status and to petition to participate in the University's phased retirement program; they also update the appointments and titles for term faculty. In addition, the proposed amendments include technical copyedits that would amend the Faculty Handbook for clarity and consistency
