All 3000/4000 level business courses require Advanced Standing which consists of the completion of 75 credits, 2.25 minimum GPA, Calculus, ECON 2100 and four of the following courses: ACCT 2300, ACCT 2310, ECON 2110, ECON 2130, BCOM 2800. MGMT 4890 requires the completion of all other business courses except for Finance major courses. Students must earn a B- or better grade in FINC 3400 to continue in the Finance major. Excel Level I Certification must be completed before graduation.
