The **Seattle University Crime & Justice Advisory Committee**, in its 19<sup>th</sup> year, works with the Department of Criminal Justice, Criminology & Forensics through our Crime & Justice Research Center to develop collaborative initiatives including research, internships, practicum courses, continuing education, and public events. Agencies on the committee and individual committee members help our students succeed in professional career advancement.

#### **Departmental Update**

#### **ENROLLMENT/STUDENT INTEREST**

We begin the 2022-2023 academic year with 340 students- 256 undergraduate students, 84 graduate students, and 7 Crime Analysis Certificate students. In the undergraduate program, forensic psychology is the most popular specialization with 101 students - 71 BA/30 BS (39% of all CJ undergrads) followed by forensic science with 60 students – 6 BA/54 BS (23% of CJ undergrads), criminology with 47 students (18% of all CJ undergrads), and administration of justice with 46 students (18% of all CJ undergrads). The most popular graduate program specializations are Investigative Criminology with 32 students (38% of all grad students) and MACJ (no specialization) with 27 students (32% of all arad students), with the remainder of the students in the Research and Evaluation specialization with 10 students (4% of all grad students), Victimology with 9 students (3.5% of all grad students), and the MACJ/JD with 3 students (2% of all grad students). We have 21 incoming MACJ students who are graduates of Boston University, Central Washington University, East Carolina University, Loras College, Northern Arizona University, Panjab University-Chandigarh, San Diego State University, San Francisco State University, Seattle Central College, Seattle University, University of Colorado-Boulder, University of Nigeria-Nsukka, University of Phoenix, University of Sunderland, University of WA-Seattle, University of WA-Tacoma, Wayne State University, and Western WA University.







#### STUDENT AWARDS AND DEPARTMENTAL HONORS

The undergraduate commencement awards include the Kelliher Award for the highest GPA in the major and the Corr Service & Ethics Award named for CJ Department co-founder Eugene Corr, former Assistant Police Chief for the Seattle Police Department honors a graduating senior in the Criminal Justice Department undergraduate program who has made significant service and ethics contributions to the criminal justice system.



In 2021-2022, we engaged in many collaborative initiatives that involved students, faculty, CJ agency partners, and alumni. Here is a sample of the projects we worked on this year.

2022 SU CJ Advisory Committee Annual Report

• Seattle Police Department's Micro-Community Policing Plans continues for its 8th year. Jacqueline Helfgott heads the SPD MCPP in collaboration with the Seattle Police Department with current Research Analysts MACJ students Ashley Dobbs (East/West Precinct), Katie Kepler (North Precinct), Brandon Bledsoe (South/Southwest Precincts), and BSCJ Forensic Science student Evelyn Madrid-Fierro (Citywide). The MCPP has employed 35 students to date as SPD civilian Research Analysts most of whom have been hired with SPD or other CJ agencies upon graduation.

Over the spring/summer 2022, the MCPP research

team conducted 15 virtual community-police dialogues that brought together community members and police to engage in conversation. This fall the team is facilitating a special series of MCPP Community-Police Dialogues for the new SPD "Before the Badge"

training program for new recruits. The dialogues focused on public safety concerns and how community and police could work together to increases public safety

and neighborhood quality of life. Reports on this research are available on SPD MCPP and CJRC websites.

• Evaluation of the Seattle Police Department's "Before the Badge" Training Program. Jacqueline Helfgott and Matt Hickman are leading a longitudinal evaluation of the Seattle Police Department's new "Before the Badge" (BTB) training program with research assistants MACJ student Bailey Tanaka and BSCJ Forensic Psychology students Stanton Shinchi and

Hailey Calcagno. The evaluation will utilize the survey instrument developed in the prior longitudinal evaluation of the WSCJTC BLEA guardian law enforcement training and will involve interviewing and collecting survey data from SPD recruits and a comparison group of WSCJTC BLEA recruits over three years.




