<p>Students in MSW Specialized Practice field are required to complete <b>720</b> hours of field for the academic year. A total of <b>240</b> hours of field is required for each quarter of the academic year. All field hours must involve social work practice at the field agency site and occur under the supervision of a qualified Practicum Instructor (PI).</p> <p><b>Students are typically in field on Tue., Wed. and Thurs. and intern a total of 24 hours per week.</b> Students are permitted to accrue field hours during the academic year. Accruing extra hours in field is not a requirement but is an option to plan for absences that may occur due to illness, religious observances or inclement weather. <b>Students in MSW Specialized Practice Field may accrue a total of no more than 24 hours for the entire academic year.</b></p> <p>Accrued hours should be recorded on the Log of Hours in Tevera®, which must be approved by the PI. Students may request use of accrued hours any time during the Fall, Winter or Spring quarters. The PI should be notified before having to be absent from field. If a student is absent and does not have accrued hours, the student is encouraged to confer with the Practicum Instructor to identify a plan for making up the hours at a future date.</p>
