## **Endorsement Budget**

Retooling applicants are required to submit an Endorsement Budget specifying the educational expenses associated with their endorsement add-on. Applicants may be awarded *up to \$3,000* of the total cost.

Please fill out the Endorsement Budget form on Page 2, completing all sections that apply to you. This form can be filled out on the computer. First download the form and save it to your computer. Then simply click on the fillable fields that are highlighted in gray and type your responses. If needed, you may fill out additional pages, indicating the Total Cost on the final page. Print out the form; then sign and date where indicated. Obtain the signature of your university representative, if needed (see instructions below\*). Submit this form along with the rest of your application materials.

\*For applicants pursuing an endorsement through a program (formerly Pathway 3):

- If you claim costs in Section I (tuition), you will need to obtain a signature from a representative at your institution of higher education who can attest to the accuracy of the costs. This representative should be a faculty or staff member from your education program (e.g., professor, certification officer, administrator of your program, etc.).
- Fill out the University Representative section at the bottom of the form, including the name of the institution as well as the name, title, and email address of your representative.
