YOU FILED YOUR FAFSA...NOW WHAT?!

The Department of Education began sending 2024-25 FAFSA data to Seattle U in March. Some students may be selected to verify information submitted on the FAFSA; SFS will send students an email if this is necessary. If you receive a request from SFS, be sure to visit mySeattleU to complete any requested documents. Financial aid offers will be released by the beginning of June.

FEDERAL STUDENT LOAN REPAYMENT CHECKLIST

- Log in to <u>www.studentaid.gov</u> to check your balance and find your loan servicer
- Update your address, phone number, and email
- Complete Direct Loan Exit Counseling
- Apply for an income-based repayment plan
- Create an online account with your servicer
- Setup Auto-pay (.25% interest rate discount)
- Contact your servicer if you are having trouble making payments
- Claim your Student Loan Interest on your taxes each year
