#### **University Update**

#### Michelle Clements, Vice President of Human Resources

- Provided a first year Council retrospective and expressed gratitude for the work of the inaugural SU Staff Council and commendation of officers: Leann, Katie, and Erin
- Staff awards chosen and will be announced in a few weeks
- Financial gap has not changed, still \$21 million deficit
- Presidential Search Update: Decision will be made public shortly and the new president will be the first non-Jesuit in Seattle University history
- Work Force strategies updates:
  - Voluntary furloughs and reduced workweeks will be offered
  - o HR is finishing its review of involuntary furloughs.
  - o All furloughs will be announced in the third week of October
  - o Cessation of 10% retirement contribution will last until June 30, 2021
  - There will be a continuation of hiring freeze but with a few critical exceptions, especially for student facing open positions

### **Leadership Team Update**

- Strategic Planning Council meetings in September and October largely focused on Academic calendar review
- SGSU has submitted a proposal for a Student Liaison to sit in an ex-officio capacity on SUSC
- Human Resources has requested Staff Council involvement in New Employee Orientation as it is moving to a virtual platform
- Staff Council member stipend proposal is in very rough form and will be handed off to the new Leadership Team for finalization
- SUSC needs to determine what list to use to reach all staff.
- Katie will add new Council members for access to SUSC email inbox
