Authors' Bios



APARNA CHANDRA (NATIONAL LAW SCHOOL OF INDIA UNIVERSITY)

Aparna Chandra is a constitutional lawyer with an expertise in Indian constitutional law among other areas. She has previously worked at the National Judicial Academy, Bhopal and the National Law University, Delhi where she founded the Centre for Constitutional Law, Policy and Governance. She has assisted the Law Commission of India in various reports and has been appointed as amicus curiae by the Delhi High Court in matters involving the interface between constitutional and criminal laws.

Aparna researches and writes on constitutional law, human rights, gender and the law, and judicial process reform. Her current research focuses on rights adjudication by courts, gender and the law, and empirical legal studies. In collaboration with the Centre for Reproductive Rights, New York, she undertook a study on legal barriers to accessing safe abortion services in India. She was also part of a European Research Council funded project by the Israel Democracy Institute on fundamental rights adjudication in various jurisdictions around the world. She is also a national co-convenor of the Indian Feminist Judgments Project.



WILLIAM HJ HUBBARD (THE UNIVERSITY OF CHICAGO LAW SCHOOL)

William H. J. Hubbard is the Deputy Dean and Harry N. Wyatt Professor of Law at the University of Chicago Law School. He received his JD with high honors from the Law School in 2000, where he was executive editor of the Law Review. He clerked for the Hon. Patrick E. Higginbotham of the US Court of Appeals for the Fifth Circuit. From 2001 to 2006, he practiced law as a litigation associate at Mayer Brown LLP in Chicago where he specialized in commercial litigation, electronic discovery, and appellate practice. From 2006 to 2011, he completed the PhD program in Economics at the University of Chicago. Before joining the faculty in 2011, he was a Kauffman Legal Research Fellow and Lecturer in Law at the Law School.

His current research primarily involves economic analysis of litigation, courts, and civil procedure. He is the author of the casebook *Civil Procedure: An Integrated Approach* (2021) and is co-author of *Court on Trial: A Data-Driven Account of the Supreme Court of India* (2023). He is a Research Professor at the American Bar Foundation and has been Editor of the *Journal of Legal Studies* since 2013.



SITAL KALANTRY (SEATTLE UNIVERSITY)

Professor Sital Kalantry is a tenured professor, associate dean, and founder of the India Center. She is an expert in comparative law, business and human rights, feminist legal theory, and contract law. Her prior book, Women's Rights and Migration, explores the consequences of the use of acontextual information to develop laws relating to reproduction in the United States. She has written over a dozen articles and book chapters that have been published in major legal journals such as the *Cornell Law Review* and the *Stanford International Law Journal* as well as peer-reviewed social sciences journals including the *Forum for Health Economics and Policy*. Her work has also appeared in the *New York Times*, *Slate*, and the *Hill* (among others). She is a regular media commentator on reproductive rights, law in India, and human rights issues. Her writing has been cited by the U.S. Supreme Court and Indian Supreme Court. Professor Kalantry teaches business and human rights, comparative constitutional law, and contract law. Her teaching is informed by her scholarship as well as her seven years of experience as a corporate lawyer at two major U.S. law firms, Milbank and O'Melveny & Myers, and by her litigation experience in international and foreign courts, including the Indian Supreme Court, Inter-American Court of Human Rights and Constitutional Court of Colombia.

DINESHA SAMARARATNE (UNIVERSITY OF COLOMBO, SRI LANKA)

Dinesha Samararatne is a Professor at the Department of Public & International Law, Faculty of Law at the University of Colombo, Sri Lanka. She has published widely, and her research interests include judicial review, public participation in constitution-making, constitutional resilience, women and constitutional law, fourth-branch institutions and the relevance of the global south in comparative constitutional law. Dinesha is a Senior Research Associate with the Laureate Program in Comparative Constitutional Law and Co-Convenor of the Constitution Transformation Network (CTN) at Melbourne Law School, Australia. She is a member of the Editorial Board of the *Indian Law Review*. In 2023, she was appointed as an independent expert to the Constitutional Council of Sri Lanka.



MARVA KHAN (LAHORE UNIVERSITY OF MANAGEMENT SCIENCES, PAKISTAN)

Marva Khan is an Assistant Professor at the Shaikh Ahmad Hassan School of Law, Lahore University of Management Sciences (LUMS). She is the Co-Editor of the LUMS Law Journal and the Co-Founder of the Pakistani Feminist Judgments Project. She completed her BA-LL.B (Hons.) from LUMS and LL.M from Harvard Law School on the Fulbright Scholarship. Her main areas of interest include constitutional law, human rights, and gender. Her recent publications include book chapters on disability rights and accessible information technology in Pakistan and special courts in Pakistan.



RONOJOY SEN (NATIONAL UNIVERSITY OF SINGAPORE)

Dr Ronojoy Sen is a Senior Research Fellow and Research Lead for Politics, Society and Governance at the Institute of South Asian Studies and the South Asian Studies Programme at the National University of Singapore. He has worked for over a decade with leading Indian newspapers, most recently as an editor for *The Times of India*. His latest book is *House of the People: Parliament and the Making of Indian Democracy* (Cambridge University Press, 2022). He is also the author of Nation at Play: A History of Sport in India (Columbia University Press/Penguin, 2015) and Articles of Faith: Religion, Secularism, *and the Indian Supreme Court* (Oxford University Press, 2010). He has edited several books, including Media at Work in China and India (Sage, 2015). Dr Sen has a PhD in Political Science from the University of Chicago and read history at Presidency College, Calcutta. He has held visiting fellowships at the National Endowment for Democracy, Washington DC, the East-West Center Washington and the International Olympic Museum, Lausanne, Switzerland.
